DREAMS was founded in 2003. In 2000 at the age of 26 (one year after getting married) the Lord began to visit me every night for three years in my dreams, hence the name DREAMS. Providing me with a vision and a true purpose for my life. At the time the task was bigger than my flesh eyes could see. His request was to **"RESTORE THEIR ESSENCE AND GRACE IN MY NAME."** and he instructed me to write. Out of these instructions the DREAMS... Don't Be Scared to Follow Them! Developing and Planning your DREAM life manual for girls was created.

Since 2004 the DREAMS organization has provided high quality enrichment programs to over 4000 youth and their families by the WOMANHOOD, SISTERHOOD & LIVELIHOOD EXPERIENCE through our EDUCATE, EMPOWER & ENCOURAGE CAMPAIGN.

THE MISSION:

D.R.E.A.M.S. Orgs. Inc is a SISTERHOOD that provides valuable information on developing into WOMANHOOD, while supplying girls life changing resources to ensure a financially stable LIVELIHOOD.

BOARD POSITIONS DUTIES:

(All Board Positions must become members of DREAMS Orgs. Inc \$25 fee)

SECRETARY: is responsible for record keeping by taking minutes at the board meetings, sending out meeting announcements, distributing copies of the minutes and agenda to each board member, keeping accurate mailing addresses for all board members and assuring that the corporation's records are maintained.

TREASURER: shall formulate financial reports, oversee the finance committee, assist in the preparation of the budget, develop fundraising plans and provide financial information to the board members and the public. The Treasurer is also responsible for maintaining, receiving, and giving receipts to the appropriate parties, and deposit moneys in the corporations banks.

DIRECTORS DUTIES: shall be a self starter, agree with the purpose and mission statement, form committees that will enhance the structure of the organization and attend quarterly meetings. Your responsibilities include heading one (1) of the following committees and be present at two (2) of the DREAMS hosted Events per year:

Events Fundraisers/Grants Community Service Programs: Dance, DREAMS Girls Talk & Sports Club

The Board of Directors position is a <u>volunteer</u> service. This position is a 2 year term. All board members are required to pay \$25.00 per year membership fee and raise through donation \$1,000 yearly to the organization by way of fundraisers, event sales, company donations and/or personal donations.
